REQUESTED ACTION

Authorize the Executive Director to amend the existing professional services agreement between the El Dorado County Transportation Commission (EDCTC) and DKS Associates (DKS), to develop the Greater Placerville Wildfire Evacuation Preparedness, Community Safety and Resiliency Plan to add \$75,000 of State Highway Account funds for additional public outreach.

BACKGROUND

On February 11, 2021, EDCTC submitted an application to Caltrans for a Fiscal Year 2021/22 Sustainable Communities Grant Application for the Greater Placerville Area Wildfire Evacuation Preparedness, Community Safety and Resiliency Plan. On June 22, 2021, Caltrans notified EDCTC that the Greater Placerville Area Wildfire Evacuation Preparedness, Community Safety and Resiliency Plan had been selected for funding in Fiscal Year 2021/22 with an award of \$250,000. EDCTC committed \$32,390 in Local Transportation Funds as matching funds. Based upon review of proposals and interviews held on February 10, 2022, via Zoom, the consulting contract was awarded to DKS on March 3, 2022, for a not-to-exceed amount of \$247,887.66.

DISCUSSION

EDCTC understands the importance of public buy-in and stakeholder consensus regarding public safety in response to a wildfire event. Given the recent Caldor and Mosquito Fires, the threat of wildfire is prominent in the minds of El Dorado County officials and residents. However, the project's original scope of work and grant application was submitted to Caltrans on February 11, 2021, months before the Caldor Fire burned 221,835 acres and destroyed 1,003 structures in the largest wildfire in El Dorado County history. To address the elevated concerns regarding wildfire evacuation preparedness, the contract executed between EDCTC and DKS on March 3, 2022, included a contingency scope of work for additional public and stakeholder outreach that EDCTC determined was necessary in the wake of the Caldor Fire. The contract stated that execution of the proposed contingency tasks depended upon EDCTC securing the necessary funds. In December 2022, EDCTC requested \$75,000 in additional funding from Caltrans to implement the additional public outreach. On January 27, 2023, Caltrans notified EDCTC that the Greater Placerville Wildfire Evacuation Preparedness, Community Safety, and Resiliency Plan was awarded \$75,000 in State Highway Account funds for additional public outreach. The existing contract's not-to-exceed amount of \$247,887.66 will be amended to a not-to-exceed amount of \$322,887.66.

REQUESTED ACTION

Authorize staff to release the Fiscal Year 2023/24 Draft Overall Work Program and Budget to Caltrans for circulation, review, and comment.

BACKGROUND

The Overall Work Program (OWP) and Budget is the primary management tool for El Dorado County Transportation Commission (EDCTC) and contains a description of the activities to be undertaken by the Commission in the coming fiscal year along with detailed budget information. The attached draft OWP and Budget has been developed in compliance with the California Department of Transportation (Caltrans) guidance for Regional Transportation Planning Agencies and has been reviewed by the Technical Advisory Committee. It is expected that the draft OWP will undergo continued refinement as staff receives comments from the Commission and Caltrans. The Draft OWP also includes the goals and objectives for the coming fiscal year. These high-level overarching goals and objectives are often carried forward from year to year but may be amended, changed, or replaced at the pleasure of the Commission.

DISCUSSION

The work elements in the OWP include on-going operations and grant funded projects. The total Draft Fiscal Year (FY) 2023/24 OWP and Budget is \$1,800,465.41. This year's proposed budget includes a cost-of-living adjustment (COLA), in accordance with the EDCTC's Personnel Policies and Procedures Manual, Section 8.4.4, Annual Cost-of-Living Adjustments. Per the Policy, the increase in the Department of Labor, Bureau of Labor Statistics, Consumer Price Index for the Western Region was used to establish the COLA from December 2021 to December 2022. The 2023/24 OWP and budget reflects a six and a half percent COLA. EDCTC staff has prepared fiscal projections which indicate that funding for current and future years can accommodate the COLA, along with a ten percent contingency for the agency.

The Goals and Objectives are presented for consideration as part of the FY 2023/24 Draft OWP to provide high-level direction and consensus for EDCTC staff and Commissioners. The goals and objectives are focused on issues and opportunities presented over the past year and expected to continue through this upcoming and future fiscal years.

The Final OWP and Budget will be reviewed in detail with the Chair and Vice Chair in April and presented for adoption at the May 4, 2023 Commission meeting.

SUBJECT: FINAL STATE ROUTE 49 AMERICAN RIVER CONFLUENCE STUDY

REQUESTED ACTION

Accept the Final State Route 49 American River Confluence Study as complete.

BACKGROUND

The El Dorado County Transportation Commission (EDCTC) was awarded a Caltrans Sustainable Transportation Planning Grant to complete the State Route 49 (SR 49) American River Confluence Study (Study). This effort was led by EDCTC in partnership with Caltrans, Placer County Transportation Planning Agency, and California State Parks. The need for this study was brought forward in early 2020, by the residents, local and regional stakeholders, and elected officials concerned about the overcrowding, accessibility, and general safety of this corridor, especially nearest the Auburn State Recreation Area located at the North and Middle Forks of the American River, known locally as "the Confluence". The fundamental purpose of this partnership initiative was to examine the SR 49 corridor from the community of Cool north to the City of Auburn to better understand the impacts of tourism and recreation, heavy truck traffic, and operations and safety in and around the Confluence.

DISCUSSION

This study was brought forward in early 2020, at the request of the residents, local and regional stakeholders, and elected officials concerned about the overcrowding, accessibility, and the general safety and operations of this corridor. EDCTC worked with the project partners and consultant to develop a scope of work to include the following:

- System User Analysis
- Parking Safety Assessment
- Roadway Safety Assessment

Throughout the development of these assessments, the project team facilitated multiple public outreach and stakeholder engagement efforts to garner input from the public and stakeholders. This was a multi-phased approach including preliminary virtual workshops, an interactive online public engagement platform, public survey, and in-person workshops. The project team summarized and integrated the input received through public engagement with the analysis and assessment reports to develop a suite of recommendations to improve operations and safety of the corridor. These recommendations were broken into the following implementation plans:

- Safe and Accessible Parking Plan
- Heavy Truck Alternatives Plan
- Transit Shuttle Plan
- Comprehensive Operations Plan

On February 2, 2023, the Draft Study was presented to the EDCTC for consideration and to receive additional feedback from Commissioners and the public. A number of comments were received and have been integrated into the final study where appropriate. The primary addition to the study

addressed the need for more information regarding project delivery and implementation. The following language has been added to the Executive Summary:

The conceptual drawings and designs in the SR 49 American River Confluence Study present a vision of potential transportation improvements in the corridor area. A project, on the other hand, utilizes specific tasks within a scope, schedule, and budget to construct transportation infrastructure such as a Class I trail, park-and-ride lot, shuttle stop and formalized parking; or roadway improvement. Concepts presented in the SR 49 American River Confluence Study may become a project when one of the agencies in the plan area that have jurisdictional authority to implement a project are able to move forward with a project within their jurisdiction. The project would then follow an approximately three to ten year process of project development before it can be constructed. The process to deliver a transportation project includes the following phases:

- allocation of funding through all project phases including construction;
- execution of Project Initiation Documents (PID);
- completion of environmental documentation required for project development under CEQA and NEPA, which includes mandatory public review and comment periods;
- acquisition of any needed right-of-way;
- completion of 100% Plans, Specifications & Estimates; and,
- construction of the project.

The recommended proposed improvement concepts will serve to inform and guide future infrastructure and programming decisions based on available funding. Information presented in this plan will also serve as a resource for EDCTC, El Dorado County, Placer County, the City of Auburn, and Caltrans for developing competitive grant applications.

BACKGROUND

To identify regional transportation project delivery issues and challenges, El Dorado County Transportation Commission (EDCTC) staff performs Planning, Programming, and Monitoring (PPM) duties for regionally significant projects in the EDCTC region. EDCTC conducts its PPM duties in collaboration with the El Dorado County Department of Transportation, City of Placerville Engineering Division, El Dorado Transit Authority, the Sacramento Area Council of Governments, and the Caltrans Department of Local Assistance.

DISCUSSION

The report includes projects funded with State Transportation Improvement Program, State Highway Operations and Protection Program, the Road Repair and Accountability Act of 2017 (Senate Bill 1) Programs, Congestion Mitigation and Air Quality, Surface Transportation Block Grant Program, Active Transportation Program, Highway Infrastructure Program, Local Transportation Fund, Bicycle/Pedestrian funds, Coronavirus Response and Relief Supplemental Appropriations Act funds, and at times, regionally significant projects funded with local funds, such as Traffic Impact Mitigation fees.

SUBJECT: DRAFT US 50 CORRIDOR ACTION PLAN

REQUESTED ACTION

None. This item is for information only.

BACKGROUND

The El Dorado County Transportation Commission (EDCTC) was awarded a Caltrans Sustainable Transportation Planning Grant to complete the US 50 Corridor System User Analysis, Investment Strategy, and Access Control Action Plan (US 50 Corridor Action Plan). Congestion on US 50 through Placerville has been a challenge for many years. This three-part planning effort set out to; 1) Conduct a system user analysis to prepare comprehensive circulation and traffic data along US 50 to update and fill data gaps; 2) Develop an investment strategy to identify and evaluate innovative pricing and funding strategies for projects along the US 50 Corridor; and, 3) Prepare an access control action plan for the US 50 Corridor within the City of Placerville to conduct a risk assessment and evaluate the circulation impacts and procedures necessary for implementation of the innovative "Trip to Green" proof of concept pilot project to close off local access to US 50 at the three signalized intersections.

DISCUSSION

EDCTC and the Project Development Team have been working since early 2021 on the three distinct components of the US 50 Corridor Action Plan. All three elements of the plan have been completed and presented to the Commission and the public, and the comprehensive Draft US 50 Corridor Action Plan has been prepared (Attachment A). Work began in 2021 with an emphasis on the Access Control Action Plan piece of the project, which was the framework for a Proof of Concept Pilot project to hold the three signals on US 50 in Placerville in a solid green phase, allowing traffic to flow freely during three key high traffic weekends. While the Caldor Fire postponed the "Trip to Green" evolution in fall of 2021, EDCTC and the project team were able to deliver the Proof of Concept during the first weekends of August, September, and October 2022. AIM Consulting supported EDCTC's efforts to ensure a comprehensive Public Awareness Plan was initiated for Trip to Green as well as a post project community survey.

In December of 2021, EDCTC staff and the US 50 Corridor Action Plan consultant team presented the initial work on the Investment Strategy element of the plan with an overview of tolling as a potential investment strategy for the US 50 Corridor. In December of 2022, the completed Draft Revenue Alternatives Memo was presented to the Commission, completing the Investment Strategy element of the comprehensive plan.

Throughout 2022, the project team continued work on data collection and traveler analysis using the Replica Geolocation Software platform. The data was analyzed by the project team and the System User Analysis element of the plan was presented in June of 2022. The System User Analysis highlights information related to traveler patterns, characteristics, trip distances, peak period congestion, and demographics of travelers on US 50.

In addition to the comprehensive outreach conducted for the Trip to Green evolution, outreach efforts were conducted for the comprehensive US 50 Corridor Action Plan, including the three components outlined above, and Community Workshops were held on December 8, 2022, January 19, 2023, and on February 16, 2023. The culmination of the work on the three components of the US 50 Corridor Action Plan, and the outreach conducted, resulted in the identification of opportunities for addressing congestion in and around downtown Placerville. These include the following:

- Do nothing;
- Continue with temporary Trip to Green operations;
- Pursue permanent Trip to Green tolled facilities for use as needed; or
- Pursue permanent infrastructure project (e.g., grade-separated permanent toll lanes)

Pros, cons, and supporting data for each of the options are outlined in the elements of the Draft US 50 Corridor Action Plan.

The Draft US 50 Corridor Action Plan will be presented to the Commission by Bryan Gant, Principal Engineer from Wood Rodgers Inc. After the presentation to the Commission, the Draft Plan will be made available for review and comment by the public on the EDCTC web page until Friday March 17, 2023. EDCTC staff will bring the final for adoption by the Commission at the April, 2023 meeting.
